<u>Issue</u>: Proposed FY 2012 Budget (July 1, 2011— June 30, 2012)

<u>Superintendent's Recommendation</u>: The superintendent recommends the Board continue its discussion on the proposed FY 2012 Budget.

Presenter: Bill Good. Patti Schroeder is available for questions.

Background: The adoption of the annual budget authorizes resources and establishes a financial direction for the district in line with the district's Ends Policies; Management Limitations 2.5, relative to Financial Planning/Budgeting and budget assumptions for the coming year, FY 2012.

The budget presented at the March 8, 2011 Board meeting works within the Board parameters, meets all requirements of the Board's Management Limitations and incorporates, to the extent possible, the recommendations of the Citizen's Budget Advisory Committee, while at the same time continuing to implement effective initiatives aimed at improving student performance, growth and achievement.

More specifically, the FY 2012 Budget covers an anticipated shortage in funding (assumes 0% allowable growth) by incorporating the following strategies:

Federal	EduJobs	\$2.2m	
Community	Property Taxes	\$2.0m	
District	Cost-cutting strategies	\$2.8m	

One of the cost-cutting strategies, as recommended by the Citizen's Budget Advisory Committee, is outsourcing a portion of the services provided by the Operations Department. The Board has asked that administration present more information and time for discussion on this strategy.

Mr. Good presented some cost comparative information regarding outsourcing custodial positions that was gathered from a sampling of other school districts where it's been done.

Ms. Link asked if Mr. Good's presentation amounted to a plan to save the district the \$1.5 million recommended by the Citizens' Budget Advisory Committee.

Mr. Good explained that he was simply outlining a methodology for achieving savings that has been utilized in other school districts. How much DMPS could save would depend on how many buildings were outsourced.

Ms. Link then asked if it might make sense to ask employee groups to make wage and benefit concessions as a means of avoiding outsourcing.

Ms. Schroeder explained that is a question that would have to be decided at the negotiations table.

Ms. Link pointed out that the Board will have to adopt a budget prior to the completion of collective bargaining with employee groups.

Ms. Schroeder said that is probably true since the law requires formal adoption of a budget by April 15.

Ms. Boesen lamented the fact that the timelines of the Board and the state legislature and the lowa Code are staggered which further complicates the annual budgeting process and leaves the Board no choice but to budget based on worst case scenarios like zero allowable growth in the case of the current year.

Mr. Gallardo asked if it is possible for the district to achieve the \$1.5 million in custodial services savings recommended by the Citizens' Budget Advisory Committee through outsourcing.

Mr. Good responded that he believes it is possible to trim that amount through outsourcing a combination of some custodial and some crafts services on a trial basis.

Ms. Caldwell-Johnson asked if there had been any discussion with the unions about the concept of a managed competition between them and outside vendors.

Ms. Schroeder and Mr. Good said such a proposal could only be discussed in the course of private negotiations.

Mr. Murphy said it feels like the Board's hands are tied because of labor negotiations. He asked if concessions by the other groups the district negotiates with could save custodial jobs.

Ms. Schroeder said if unexpected savings were realized in collective bargaining that information would be brought back so the Board could entertain some other options

Mr. Murphy suggested that the three groups who negotiate with the district get together and discuss ways amongst themselves that job cuts due to inadequate school funding can be minimized or even avoided altogether.
